BASKETBALL MANAWATŪ PLAYER PARTICIPATION POLICY



PURPOSE

The purpose of this policy is to provide a framework for the administration of player payments for Leagues/Tournaments/Events and other acitivities payable to Basketball Manawatū. Whilst always acknowledging the financial strain some individuals/families may be under at difficult times, Basketball Manawatū is expected to ensure financial equality for all participants in our activities around their paying to play.

SCOPE OF THIS POLICY

This policy applies to all "pay to play" activities offered by Basketball Manawatū, including but not limited to:

- KiwiHoops programme.
- Other community-based programmes.
- Weekly Schools competitions.
- Adult Social and Competitive competitions (Summer and Winter Leagues).
- Representative Teams.

Basketball Manawatū relies on player fees to pay for purchase of equipment (& it's maintenance), venue hire, wages and salary, insurance and other programme operating costs.

They include any player subs that are required to be paid by Basketball Manawatū to our National Body (Basketball New Zealand) or to any third party who may be involved in our activities (e.g. Glory League). The fees are set by the Basketball Manawatū Board each year and are communicated to members via website, other social media modes and with ample time to pay off before the start of the activity.

TIMELINE TEMPLATE

The timeline template for League, or Competition activities offered by Basketball Manawatū, is set out in the table attached as Appendix One and shall be used each year to set fees and timelines.

UNPAID FEES FROM PREVIOUS SEASON ("No Pay-No Play")

If a player that registered in the previous year/season still has unpaid full fees or part fees, he/she will not be permitted to participate in any Basketball Manawatū activities until that debt is cleared or an agreed repayment plan is instigated to repay it (together with this current year's activity fees

A player will also not be allowed to compete in a new team, if the previous seasons debt was incurred for another team.

POLICY REVIEW

Basketball Manawatū will monitor and review this policy on an annual basis.

Interim Addendum to this Policy (For 2022)

Covid-19 ("No Pay-No Play")

It is reaffirmed that whilst always acknowledging the financial strain some individuals/families may be under at difficult times, Basketball Manawatū is expected to ensure financial equality for all participants in our activities around their paying to play.

In light of the unprecedented situation we all find ourselves in at this time the current board of Basketball Manawatū agrees that there is a need to be a little lenient toward those who still owe us money for unpaid Rep or Leagues fees.

Provided we have a signed agreement (including an accepted amount and frequency) that a debtor shall regularly repay the debt until it is repaid in full; then we shall allow them to play in our competition, or any BBNZ comp, that may be held.

The General Manager of Basketball Manawatu has the Board's approval to: -

- 1. Negotiate and implement payment plan arrangements, where the receipts due under a payment plan outweigh any administrative costs associated with that payment plan.
- Negotiate and implement payment for services plan arrangements, where the activity is appropriate for the individual and payments outweigh any additional costs associated with that plan, e.g., offsetting any referee or Scorebench duty fees against the debt; or any CET Arena or other fundraising activities.

The above then still allows players to play in the 2022 Competition provided that the agreement is adhered to by the debtor in an acceptable timeframe.
